Statements having been filed with the City Clerk, May 4, 1917, before five o'clock P.M., and transmitted by him to this board, - signed and sworn to by Charles E. Hunt, a registered voter of ward one, and signed by nine other registered voters of said ward; signed and sworn to by Charles M. Davis, a registered voter of ward three, and signed by nine other registered voters of said ward; signed and sworn to by Leonard B. Chandler, a registered voter of ward four, and signed by ten other registered voters of said ward; signed and sworn to by Charles F. Sugg, a registered voter of ward five, and signed by nine other registered voters of said ward; signed and sworn to by Hiram Turner, a registered voter of ward six, and signed by nine other registered voters of said ward; and signed and sworn to by John Jack, a registered voter of ward seven and signed by nine other registered voters of said ward; to the effect that the said registered voters of said wards believe and have reason to believe that the records or copies of records made by the election officers of the said wards are erroneous in that Elbridge G. Davis was credited with more votes and Frank A. Bayrd was credited with fewer votes according to the records than were really cast for them and that the said registered voters believe that a recount of the ballots will affect the election of Frank A. Bayrd and respectfully asking for a recount of said ballots; and the City Clerk having delivered to this board the boxes containing the ballots cast in all of the voting precincts in said wards at the election held therein May 1, 1917, and this board having given notice in writing to the several candidates interested in and liable to be affected thereby, that it would meet at the City Hall, this Monday, May 7, 1917, at 7.30 o'clock P.M., for the purpose of recounting the votes cast for Delegates to the Constitutional Convention from the Ninth Congressional District, and this board having met at the said time and place, and opened the boxes containing said ballots cast in wards one, three, four and in precincts one and two of ward five, and having recounted the votes cast on said ballots for Delegates to the Constitutional Convention from the Ninth Congressional District, and having returned said ballots to said boxes and re-sealed said boxes and certified thereon as required by law, and having adjourned to again meet this Tuesday, May 8, 1917, at 7.30 o'clock P.M., and having again met at the said time and place, and opened the boxes containing said ballots cast in precinct three of ward five and in wards six and seven, and having recounted the votes cast on said ballots for Delegates to the Constitutional Convention from the Ninth Congressional District, and having returned said ballots to said boxes and re-sealed said boxes and certified thereon as required by law, the candidates interested as aforesaid having been present or represented by agents appointed by them in writing at said recount as follows, namely,-

At the meeting of May 7, E. Talladge Root was present; none of the other candidates or their agents were present.

At the meeting of May 8, No candidates or their agents were present.
